The institute office related functions are originated and managed by using the ERP software "EPrashasan'. It consists of the modules 1. Student admission where in the student admission data is managed. 2. General Register which consists of all the detail data of the student admitted, 3. Fees management through which we generate receipt and challan of college fees for the student, and 4. Group SMS (Bulk SMS) module which is used to send information to all stakeholders such as students, parents, staff and faculty in the form of short notices. The accounts of the institute including admission fees, payments etc are managed through Tally software. The library is equipped with OPAC (Online Public Access Catalogue) system which enables the students to search the library catalogue and check the availability of books by either title, author or	

subject. The LMS is managed through VM Edulife which is a cloud based learning platform provider for our institute. This online platform is accessible for all stakeholders. The innovative tools facilitate the management for faculty, HODs, Principal and Management to generate reports with ease which helps to make well informed decisions. It is reliable and transparent software solution for LMS. It has various modules such as 1. Outcome based education module that has built in digital depository and decision making tool which helps in generation of report. 2. Rubrics which play an important role for communicating faculty expectations to students in the assessment. It is a powerful tool for assessment and grading of individual as well as multiple students work. 3. Learning Management system which is used for administration, documentation, tracking, reporting, automation and delivery of educational courses, training programmes or learning and development programmes. 4. Assignments module enables the educators to assess and track the progress of students. 5. Examination module helps the educators to conduct internal class tests online, which became very useful when the Covid 19 pandemic started. 6. IQAC module plays a key role for conscious, consistent and catalytic improvement in the overall performance of the institute. 7. LeaderBoard module which monitors the activity of any user on the VM Edulife portal. This is monitored with the help of credit points gained by the user (teacher/student) while performing various activities on the platform. 8. Grievance Redressal system This module is used to manage and redress grievances with greater transperancy and positive ambiance. 9. Fees management module which is well designed with supreme features and latest integration of payment gateways mode which helps instant and hassle free fee collection process generating multiple reports with just one click. 10. Event management module which helps effortless planning and coordination of events keeping track of these events. 11. Academic module in which the faculty manages the academic activities

Institution has well planned mechanism for delivery of curriculum and documentation. The college has set process for the effective and efficient delivery of the syllabus. In this process, the academic calendar and workload of the faculty has been designed and formulated. Subsequently, the time table is designed and disseminated to students. The college is very keen and rigid for the adherence to academic calendar not only for the smooth completion of academic activities but also for the pursuit of quality enhancement and sustenance. College follows curriculum prescribed by Savitribai Phule Pune University. Academic calendar is designed in accordance with circulars issued by Savitribai Phule Pune University as well as list of holidays declared are followed to decide commencement and conclusion of the academic term in academic calendar. Academic calendar is designed as per the activities for the academic year discussed in Internal Quality Assurance Cell (IQAC) by the academic monitoring committee appointed by Principal in consultation with HODs of all departments, in-charge of examination department, National Service scheme (NSS) coordinator and in-charge of co-curricular and extracurricular activities. The academic calendar encompasses term schedule, total number of instructional days, tentative dates for sessional examinations and vacations. It also include tentative schedule of co-curricular, extra-curricular and other academic events, instructions regarding library usage and general rules. Besides, the procurement and compilation of learning tools is reviewed and completed by the faculty. The concerned faculty prepares and disseminates the tentative teaching schedule to the students for the effective delivery of the curriculum. Meanwhile, academic monitoring is confined in order to review the partial completion of the syllabus. During the delivery of the syllabus, continuous assessment of the students is carried out as and when required. Students' feedback is sought about the effective delivery of the syllabus. Lastly syllabus completion report is communicated to academic coordinator. Moreover, the extent of compliance of university curriculum is identified from getting feedbacks from different stake holders (Course Exit Feedback, Employers Feedback, Peers (Examiners) feedback, Alumni feedback, Parent Feedback). The college has a rigorous feedback mechanism for the effective implementation of curriculum process. In this process, feedback forms have been provided to the students of all classes in order to ensure transparency and accountability. The curriculum prescribed by Savitribai Phule Pune University has been followed meticulously. The delivery of the curriculum is attained by providing text books, reference books, e-books, e-journals, scientific journals, laboratory manuals, quick reviews, question bank, copies of the projects, charts, models and learning modules of NPTEL. In this process, concerted and continuous efforts are required to make the pedagogical initiatives influential, impactful, fruitful and meaningful to achieve the desired results. The faculty of the college has used variety of instructional methods to make the pedagogy effective and deliverable. Faculty does use the methods like powerpoint presentations, animations, graphs, charts and video clips to enhance the

Feedback Obtained

The college has a rigorous feedback mechanism for the effective implementation of curriculum enrichment. College opts following feedbacks which is being analyzed and utilized for overall development of the institution: Students' feedback on industrial training: College is very particular about getting feedback for those students who have successfully completed industrial training for 1 month. The aim of this feedback is to assess and review the hands on experience and skill by students during the completion of this exercise. In this context, students get varied experience for the operation of equipments, standardization processes, analysis and marketability of the products. Many students have revealed that they have enhanced their competencies and competitiveness by correlating hard skills (domain knowledge) with the work place under the supervision of industrial experts. 2.3.2 – Students mentoring system available in the institution? Give details. (maximum 500 words)

The college adopts a unique method of counseling/ mentoring for the holistic development of learners in which faculties have been assigned a group of 10 students for mentoring and academic guidance. The faculty, however, shares his/her personal and professional experiences with students during mentoring. Students are equipped with various skill sets like problem solving skills, communication skill, analytical skill, logical skill and real world skill and employable skill to boost the confidence and competence of the learners. Student-mentoring has been initiated with the aims to enhance teacher-student interaction, to enhance students' academic performance and attendance, to minimize student drop-out rates and to bring slow learners at par with advanced learners and to bring out personal and professional grooming of students with relevance to the career development. Mentoring includes course work specific mentoring, laboratory specific mentoring, professional guidance and career advancement mentoring regarding self-employment opportunities, entrepreneurship development, morale, honesty and integrity required for career growth. For mentorship a group of 10 students were assigned to mentor. This faculty will continue to be mentors for the assigned group of students till their graduation. However students can contact any faculty regarding academic issues or personal problems with prior appointment. The mentor after collecting all necessary information from mentee renders guidance and counseling, as and when required. Mentors are required to conduct at least one counseling session in three months. Mentors are expected to maintain reports of each session in the given format. The report is submitted to in-charge of student mentoring system at the end of an academic year. In special cases, parents are called for counseling/special meetings with the Principal as per suggestion of the mentor.

aim of this method of learning is to make the process more interactive, accessible and reflective Context and Practice: In this exercise, a group of 3-4 students have been identified and assigned experiment incorporated in the curriculum. The students are given detail inputs about the theory, logic and significance of the experiment. Subsequently student experiment, reflect and conceptualize during the experimentation. One participant of the group elaborates the protocol, requirements. The second participant explains about the working and handling of the equipment, while the third participant elaborates about the reflective ideas and, the fourth participant highlights the conclusion of experiment. All the steps in the experiment are carefully video recorded and used as reference for other students for motivation Evidence of success: In fact, this learning method basically encompasses concrete learning, reflective observation, abstract conceptualization and active experimentation. The learners are attracted to new challenge and solve the problem intuitively. This learning process also involves conceiving new ideas, evaluation, analysis, interpretation, generalization and factual conclusion. Learners do apply intuitive skills to achieve and attain desired learning objectives. By and large, learners develop multidimensional thinking, lateral thinking, critical thinking, analytical ability, and application skills
