WHEREAS

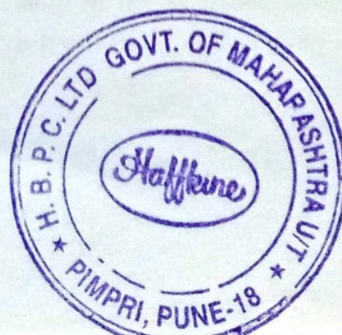

First Party is the amongst the premium Pharmacy institutes imparting quality education in a sector of Pharmaceutical Sciences as well as carrying out research in Pharmaceutical Sciences. It is established in 1998 in Pimpri-Chinchwad industrial belt and run by Progressive Education Society Pune-5. It offers Undergraduate (B. Pharm.), Pharm D, Post graduate (M. Pharm) and Doctoral courses (Ph.D) in Pharmacy. All the courses are recognized by Pharmacy Council of India (PCI), Institute is affiliated to Savitribai Phule Pune University, Pune, Approved by All India Council for Technical Education (AICTE), Maharashtra State Board of Technical Education and also approved under 2(f) and 12 (B) of the UGC Act. With the relentless efforts of dedicated and competent faculty, up-dated curriculum, innovative methods of instructions top end infrastructure and sturdy support of management, it has emerged as a center of academic excellence and attracting students from all over India. Whereas the second party is also engaged in research in Pharmaceutical Sciences.

WHEREAS

Second Party is Haffkine Bio-Pharmaceutical Corporation Ltd. It is the pioneer in the production of anti snake venom serum in India and has been producing it since 1940. Even the lyophilized anti snake venom serum has been introduced by Haffkine Bio-Pharmaceutical Corporation Ltd in the country since 1945. Earlier it used to be the largest manufacturer of anti snake venom serum in the country producing about 60 – 70% of the country's total production. Anti snake venom serum produced by Haffkine Bio-Pharmaceutical Corporation Ltd has even been exported to neighboring countries through WHO and UNICEF. NOW THEREFORE THIS MEMORANDUM OF UNDERSTANDING WITNESSE AS UNDER

1. Field of Co-Operation:

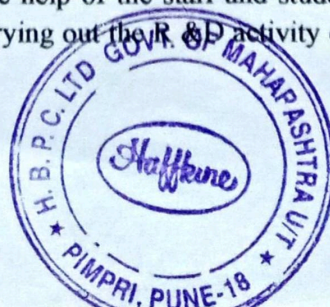
2. Management and Administration:

- d. The findings of the research work shall be published or patent jointly by the parties.
- e. If the results of this joint project are able to attract commercial utilization, then the financial benefit shall be shared between the two parties equally or through any mutually agreed arrangements.
- f. Both parties should follow rules and regulations during said activities in the premises.

4. Amendments:

This Memorandum of Understanding may be amended, if required, by mutual agreement between both the parties, formalized by an exchange of letters specifying the date of entry into force.

7. Valid period:

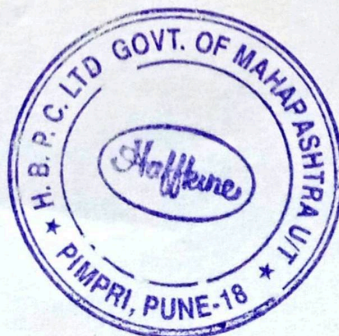
